Drug Screening Services

5 Panel Urinalysis

Amphetamines, Cocaine, Opiates, PCP and Marijuana. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO.

*Average turnaround time: 1-3 business days after applicant submits sample

** 3rd party collection site fees are applied and may be billed separately as needed.

8 Panel Urinalysis

Amphetamines, Cocaine, Opiates, PCP, Marijuana, Barbiturates, Benzodiazepines and Methadone. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO.

10 Panel Urinalysis

Amphetamines, Cocaine, Opiates, PCP, Marijuana, Barbiturates, Benzodiazepines, Methadone, Propoxyphene, and Methaqualone. All positive results are automatically confirmed through Gas Chromatography/ Mass Spectrometry. A MRO (Medical Review Officer who is a medical doctor and an expert in the substance abuse field) will review any screenings with positive results.

5-Panel Urinalysis with Expanded Opiates

Amphetamines, Cocaine, Opiates, PCP, Marijuana and Oxycodone. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO. *Average turnaround time: 1-3 business days after applicant submits sample ** 3rd party collection site fees are applied and may be billed separately as needed.

10-Panel Urinalysis with Expanded Opiates

Amphetamines, Cocaine, Opiates, PCP, Marijuana, Barbiturates, Benzodiazepines, Methadone, Propoxyphene, Methaqualone and Oxycodone. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO.

5-Panel Hair

Amphetamines, Cocaine, Opiates, PCP and Marijuana. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO.

5-Panel Saliva

Healthcare Panel Urinalysis

Amphetamines, Cocaine, Opiates, PCP, Marijuana, Barbiturates, Benzodiazepines, Methadone, Propoxyphene, Methaqualone, Fentanyl, Tramadol, Meperidine and Oxycodone. Some of the above drugs are tested at lower cut-off levels than a standard drug screen. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO.

Steroid Panel Urinalysis

Panel including Anabolic steroids, masking agents, stimulants, narcotics, betablockers & diuretics. Includes collection, initial screen, confirmation GC/MS screen if needed, and MRO.

DOT 5-Panel Urinalysis

Amphetamines, Cocaine, Opiates, PCP and Marijuana. Fee includes collection, initial screen, confirmation GC/MS screen if needed, and MRO. Review all according to DOT Regulations 49 CFR Part 40.
